## CASE STUDIES

### FPC / Alcoa / Simcoa

#### Scope of Work:

- Tree harvesting, pre-mine clearing, and secondary timber residue recovery.
- Efficient management of four separate contracts under a single integrated operation.
- Complete elimination of timber residue burning through recovery and commercial repurposing.

**Outcome:** JRM successfully streamlined operations, reducing environmental impact and improving resource utilisation. By integrating multiple contracts into a single workflow, JRM enhanced efficiency, sustainability, and cost-effectiveness for all stakeholders.

### Alcoa - Pinjarra

#### Scope of Work:

- 250m<sup>3</sup> remediation buttress construction to stabilise mine site drainage.
- Dewatering and drain stabilisation, including coil and drainage installation.
- HDPE welding for pressure and drainage pipes.
- Foundation preparation and precise material placement for long-term stability.

**Outcome:** JRM executed a complex and highly detailed earthworks project, meeting strict material specifications and delivering within the required timeline.

### Alcoa - Arundel


#### Scope of Work:

- Excavation and construction of two 50ML water storage dams.
- High-spec drill & blast alongside critical infrastructure.
- Detailed earthworks with stringent material testing and compliance.
- Installation of HDPE lining, revetment matting, and fencing.

**Outcome:** JRM successfully delivered this highly detailed project, meeting strict engineering standards while maintaining operational efficiency and environmental compliance.
